Hottrax Motorsport are proud to announce an official ACU test day (Permit Number: 27885) at Oulton Park in Cheshire. The event is promoted by Hottrax Motorsport Racing Club Ltd and held under the National Sporting Code and Standing Regulations of the Auto Cycle Union and these Supplementary Regulations together with any final instructions subsequently issued or Official Announcements made.

2. Eligibility

Open to riders of 16 years of age or above and who are members of Hottrax Motorsport Racing Club Ltd. Minimum licence requirement – ACU Clubman, SACU Qualifiers Licence or an FIM International Licence. The Road Race Licence must be valid and be issued by the ACU, Scottish ACU or a licence with Start Permission and Insurance to FIM minimum standards for road racing issued by an FMN that is affiliated to the UEM. Licences must be produced when signing on.

3. Entries and Fees

All entries must be made on the official entry form accompanied by the correct payment or on our web site and the entry form must be handed in at registration on the event.  
 Cheques must be made payable to Hottrax Motorsport Racing Club Ltd. Credit cards are accepted but are subject to a 3% charge on top of the race entry.

Non club members will be charged an additional £10 for inclusion in the test day.

We reserve the right to refuse any entry or to abandon, cancel or postpone the event or alter the programme of events. In the event that you wish to cancel your entry before 10 days prior to the event you will be entitled to a credit note less 15% for administration costs. The credit note is valid until the end of 2011. Cancellation within 10 days of the event will result in the loss of the complete amount and no refunds or credit notes will be issued.

4. Limitation of Riders

All groups – A maximum of 60 riders on track

5. Change or Rider and/or Machine

Changes are allowed at any time

6. Awards Presented On The Day

There are no awards on test days

7. Programme of the event

Registration – Race Admin – From 07.30

First group on track – 09.00

Lunch break – 13.00 to 14.00

End of the event – 17.00 or dusk

All timings are subject to change

There are 3 groups each being allocated 20 minute sessions throughout the day. The groups are given colours Blue, Red and Green.

8. Course

The 2.692 mile circuit, permanent course licence number 004, run in a clockwise direction

9. Technical Inspection and Noise Control

It is the riders responsibility to ensure that their machine complies with the regulations and is fit to take part in the test day.

The noise limit for the day is 105db static tested by Oulton Park staff using calibrated equipment. Failure to adhere to the noise level will mean you cannot ride on the circuit and your fees will be forfeit. All machines must be tested before being allowed on the circuit.

10. Circuit Entrance

The circuit will be entered from the pit lane into Cascades corner. Each session start times will be announced by tannoy system.

11. Finish of the sessions

The chequered flag will indicate the end of each session and will be displayed on the start straight before Old Hall corner.

12. Tyres

Any type or style of tyre may be used including slick racing tyres and wet weather tyres.

13. Parking and Garages

Parking is available free of charge and it is free to park where you like. Garages are free and available on a first come, first served basis.

14. Rider Identification – Endurance Only

Riders will be given a wrist band by the circuit and a sticker for their bike. These must be displayed at all times.

15. Pit Stops

These are allowed and must be taken in the official pit lane.

16. Repairs and Adjustments

Any repairs and adjustments must be carried out in the paddock and not in the track.

17. Fuel

Fuel must be held in sealed metal containers. Not more than one container of fuel with a maximum capacity of 25 liters may be held by any team in their depot at any time. Any type of normal pump fuel may be used.

18. Safety Car Deployment

The safety car is not being used at this event

19. Interpretation

The interpretation of these regulations or final instructions rest with the Clerk of the Course, subject to the normal rights of appeal. These instructions are subject to change at any time with the approval of the ACU and Hottrax Motorsport personnel.
